TERMS AND CONDITIONS

Welcome to the **Liquida Grant**!

This document defines the Terms and Conditions that define the Liquida Grant application. These Terms and Conditions apply between the User and PRS Srl Impresa Sociale (henceforth referred to more simply as Paratissima), the Italy-based corporation headquartered in Via Mazzini 25, 10123, Torino, Italy, P.IVA 11800270016, operational owner of the website paratissima.it, prs.arte, artiglieria.art and all the related websites and services.

By checking the Terms and Conditions box, completing the Award application process, and completing payment of the participation fee, you are taking part in the Liquida Grant 2023, hereby acknowledging that you are bound by the following Terms and Conditions.

Please read them carefully before applying for the application.

1. Grant rules

Applications for the Liquida Grant open on January 10, 2023 and close on March 20, 2023. Participants can enter by clicking on the "Apply Now" button available on [this page](#) and following the application process. Each participant can apply for the Award in either of the different ways of participation outlined in pt 1.1.

1.1 Mode of participation

The applicant can choose to participate in the Liquida Grant in two different ways, depending on the content he or she intends to present:

1) **ONE SHOT**: if the applicant wants to participate in the Liquida Grant with a single shot, the application must include a minimum of 1 shot up to a maximum of 5 shots.

The jury of professionals will select 10 shots by 10 authors from all those submitted (each author may be selected with only one shot from those submitted in the application). Images must be uploaded in .Jpg or Jpeg format and each image cannot exceed 10MB.

The theme of the submitted shots is FREE. Each shot can be untethered from the others and multiple types of shots pertaining to different types of research may be submitted.

The cost of participation in this type of application is **€25.00**, which must be paid at the same time as submitting the application via the payment methods explained in pt.1.2.

Please note that payment of the fee does not guarantee automatic selection. In addition, the amount will NOT be refunded in case of non-selection.

2) **FULL PROJECT**: this mode of participation involves an entire photographic project consisting of a minimum of 6 up to a maximum of 10 shots. In the dedicated Google Form, it will also be necessary to include an abstract in order to illustrate the project concept, a fundamental element for the evaluation of the application by the Award Jury.

The theme of the submitted projects is FREE. It is important that all shots submitted can be traced back to the same photo-

graphic project.

Images must be uploaded in .Jpg or Jpeg format and each image cannot exceed 10MB.

The cost of participation in this type of application is **€40.00**, which must be paid at the same time as submitting the application via the payment methods explained in pt.1.2.

Please note that payment of the fee does not guarantee automatic selection. In addition, the amount will NOT be refunded in case of non-selection.

The selected candidates will be required to send the files of the awarded shots in high resolution according to the modalities indicated in the selection notice that will arrive via email.

Paratissima will bear all costs of production, set-up, dismantling, transportation to any other exhibition venues and promotion of all related events. Visibility will be given on Paratissima's official social channels to the submissions deemed most valuable, regardless of whether or not they are selected.

By accepting these Terms you agree that the judges' decisions are final on all matters related to the Liquida Grant.

2. Prizes & Judges

The Liquida Grant will offer the following **prizes**:

a) **SOLO SHOW**: Exhibition of the winning project from the entries received in the FULL PROJECT category during the Liquida Photofestival from May 04 to May 07, 2023 in the spaces of the Cavallerizza Reale, Via Verdi 5, 10124, Turin

>>> **1 winning project**

b) **GROUP SHOW**: Exhibition of the 10 winning shots among the entries received in the ONE SHOT category during the Liquida Photofestival from May 04 to May 07, 2023 in the spaces of the Cavallerizza Reale, in Via Verdi 5, 10124, Turin

>>> **10 winning shots**

Additional Awards and **members of the Jury** will be announced through the official channels of Paratissima and Liquida Photofestival 2023.

3. Candidates undertakings

By ticking the Terms and Conditions box and completing the entry fee payment, your Liquida Grant submission will be official, and You hereby acknowledge and agree to be bound by these Terms and Conditions.

By accepting these Terms and entering the Liquida Grant, You guarantee that all the information submitted is true, current, and complete, that You are the copyright owner of any copyright works submitted, and that Paratissima's use of such works will not infringe the rights of any third party; You also fully indemnify Paratissima and Liquida Photofestival of any infringement.

You also acknowledge that the full names of the winners may be published by Paratissima, and You grant to Paratissima a non-exclusive perpetual, worldwide royalty free license to use and publish your entries in whole or in part in any media form whatsoever, for the sole purposes of the current and future Grant's editions promotion.

If the photographs contain any material or elements that are not owned by the Entrant and/or that are subject to the rights of third parties, and/or if any persons appear in the photograph, the Entrant is responsible for obtaining, prior to submission of the photograph, any and all releases and consents necessary to permit the publication, exhibition and use of the photograph in the manner set forth in these Terms without additional compensation. If any person appearing in any photograph is under the age of majority in their state/province/territory of residence the signature of a parent or legal guardian is required on each release.

4. Paratissima undertakings

Paratissima will notify each prize winner at the email address associated to the respective winners'. The winner will have 7 days from the day he or she will be notified to answer Paratissima and claim the Prize. If Paratissima is unable to notify the winner, or if the winner fails to respond within the fixed time period as specified, this may result in forfeiture of the prize and Paratissima reserves the right to select an alternative winner in accordance with these Terms and the Grant information.

Paratissima commits to always mention the author copyrights.

When You submit photographs to the Liquida application, You remain the copyright owner of the photographs You submit to the Liquida application and Paratissima does not claim ownership over the photographs.

5. Licences/releases

By ticking the Terms and Conditions box and completing the entry fee payment, You submit Your works to the Liquida Grant and You declare that:

- a) You can lawfully enter into contracts under applicable law;
- b) You have obtained and have copies of model releases from all subjects depicted in the photograph(s) You submit to the Liquida Grant, and such persons voluntarily consented to publication and/or dissemination of their likeness for all legal purposes.

Neither Paratissima nor their associates, affiliates or partners assume any responsibility for photos submitted in violation of these Terms. Images that demonstrate violations on copyright and/or Grant policies will be removed & disqualified by Paratissima after due investigations.

6. Limitation of liability

By participating, Entrants agree to release, discharge, and hold harmless Paratissima and each of their respective partners, affiliates, subsidiaries, advertising agencies, agents and their employees, officers, directors, and representatives from any claims, losses, and damages arising out of their participation in the Liquida Grant-related activities.
